- 5. Association of Washington Cities Member Standards Training for Boards & Commissions: Mr. Kennedy provided an overview of training requirements of the Association of Washington Cities (AWC), the City's insurance and risk pool insurance provider. AWC's Risk Management Service Agency (RMSA) outlines the requirements for all elected officials, board or commissions and all employees. The entire council, board, or commission and appointed records officers shall receive training on open public meetings, public records requests, and records retention and take a refresher training every three (3) years.
